CAMPUS REGULATIONS	<p>The permit holder and all in the group of the permit holder understand and agree to adhere to the following campus regulations:</p> <p>Access and photography in any and all buildings, including those otherwise open to the public, is not permitted.</p> <p>Parents and/or guardians must accompany children under the age of 18 at all times.</p> <p>No water access is permitted including, but not limited to swimming, wading and/or sunbathing.</p> <p>The use of boats or any and all water flotation devices or crafts are not permitted.</p> <p>Picnicking, coolers, blankets, tents, etc. are not permitted.</p> <p>Alcoholic beverages, gambling and wagering are not permitted.</p> <p>Only service animals are permitted on the campus grounds.</p> <p>The use of drones is not permitted.</p> <p>Public parking is only available in the Purple Parking lot or along Principal Avenue in the marked parking spots.</p> <p>Trolleys, buses, and limos are prohibited.</p> <p>Recommended access to campus is through the entrance from Highway 45 and not from Route 176.</p> <p>No photos may be taken on the bridges or in the roadways on campus.</p> <p>All areas of the campus grounds will be respected and kept in excellent condition and all trash will be properly disposed of or taken with upon departure.</p> <p>While exploring outdoor spaces, a sense of sacredness and an atmosphere conducive to prayer and reflection must be observed.</p> <p>All directions of the USML Public Safety officers, USML administrators, and USML signage will be followed at all times.</p>
