CAMPUS REGULATIONS	The permit holder and all in the group of the permit holder understand and agree to adhere to the following campus regulations:	
	Access and photography in any and all buildings, including those otherwise open to the public, is not permitted.	
	Parents and/or guardians must accompany children under the age of 18 at all times.	
	No water access is permitted including, but not limited to swimming, wading and/or sunbathing.	
	The use of boats or any and all water flotation devices or crafts are not permitted.	
	Picnicking, coolers, blankets, tents, etc. are not permitted.	
	Alcoholic beverages, gambling and wagering are not permitted.	
	Only service animals are permitted on the campus grounds.	
	The use of drones is not permitted.	
	Public parking is only available in the Purple Parking lot or along Principal Avenue in the marked parking spots.	
	Trolleys, buses, and limos are prohibited.	
	Recommended access to campus is through the entrance from Highway 45 and not from Route 176.	
	No photos may be taken on the bridges or in the roadways on campus.	
	All areas of the campus grounds will be respected and kept in excellent condition and all trash will be properly disposed of or taken with upon departure.	
	While exploring outdoor spaces, a sense of sacredness and an atmosphere conducive to prayer and reflection must be observed.	
	All directions of the USML Public Safety officers, USML administrators, and USML signage will be followed at all times.	
CANCELLATION CLAUSE	This permit may be canceled for violation of any campus regulations by either the permit holder and/or person within the party of the permit holder.
