Masks may be lowered/removed once the photo is staged and the photographer is ready to take the photo and then the masks must be immediately placed back on.</p> <p>Access and photography in any and all buildings, including those otherwise open to the public cannot be permitted.</p> <p>No public washrooms are available at this time.</p> <p>Parents and/or guardians must accompany children under the age of 18 at all times.</p> <p>The use of boats or any and all water flotation devices or crafts are not permitted.</p> <p>No water access is permitted including, but not limited to swimming, wading and/or sunbathing.</p> <p>Picnicking, coolers, blankets, tents, etc. are not permitted.</p> <p>Alcoholic beverages, gambling and wagering are not permitted.</p> <p>Only service animals are permitted on the campus grounds.</p> <p>All areas of the campus grounds will be respected and kept in excellent condition and all trash will be properly disposed of or taken with upon departure.</p> <p>Public parking is only available in the Purple Parking lot or along Principal Avenue in the marked parking spots.</p> <p>Access to campus is from Highway 45 and not from Route 176.</p> <p>All directions of the USML Public Safety officers, USML administrators, and USML signage will be followed at all times.</p> <p><b>This permit may be cancelled for violation of any campus regulations by either the permit holder and/or person within the party of the permit holder.</b></p> <p>I, the undersigned understand that the University of St. Mary of the Lake/Mundelein Seminary and/or Archdiocese of Chicago assumes no liability for accidents, injuries, losses or damages incurred by myself or anyone in my party while on its premises.</p>
